The appointment of the above doctors is further subject to the following terms and conditions:-

1. Before joining the Department the selected candidate shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
  - a. he is Non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
  - b. he will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.

- c. he shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
  - d. he is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
  - e. he leaving the job in midway shall not be entitled for any experience certificate.
  - f. he will not indulge himself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.
2. The above NPSC doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement format of Form A can be downloaded from our college website.
  3. Due to Covid-19 pandemic, the appointee is required to join within (07) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidate is supposed to submit her joining report in the office of the Registrar Academics, Government Medical College, Srinagar before he will directed to report to the concerned Department.
