Pursuant to selection list issued vide notification No: NGS/MC/21/Final-Sel/ANM/AAB-NHM dated: 01.03.2021, sanction is hereby accorded to the provisional engagement of the candidates annexed in Annexure-A to this order as ANMs in the pay scale Level-2 (19900-63200) on Academic Arrangement Basis in terms of SRO-24 of 2019 dated: 10.01.2019 in Govt. Medical College, Sgr. for a period of one year only or till such time the posts are filled by the competent authority whichever is earlier:-

The above engagement shall be subject to the following terms and conditions:-

A	Pay scale and salary	Consolidated pay equal to the revised basic pay, which corresponds to the minimum of the Pay Scale level-2 (19900-63200) plus Dearness Allowance. The Engagees shall also be entitled to HRA as applicable to in-service candidates carrying the minimum of revised scale subject to the fulfillment of conditions provided under relevant rules in this regard. Engagees shall not be entitled to any other monetary benefits, whatsoever.
B	Date of commencement of one year appointment	Date of signing of agreement.
C	Other conditions of Service	Engagement shall be terminable on either side by prior notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. Engagement shall be terminable without any further notice, whenever the posts are filled - up under rules by the competent authority and the engagees shall have no claim, whatsoever, against the Government or the Appointing Authority. In the matter of discipline and conduct, the engagees shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject.

D	Agreement to be signed	The engagees shall be allowed to join only after they sign an agreement as per format prescribed as Form-A appended to SRO-24 of 2019 dated: 10.01.2019.
E	Nature of engagement	The engagement made herein shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the engagees for regular appointment against the post of ANMs.



The engaged candidates shall report to the office of the undersigned within a period of 21 days positively and shall be allowed to join on the production of the following certificates in original and signing of the requisite agreement as mentioned above. The candidates who fail to join within a period of 21 days from the date of issuance of the engagement order shall forego their right to engagement which shall be deemed to have been cancelled abinitio without any further notice and the candidate next in the merit shall be considered for engagement as ANM.

01. Matriculation (Date of Birth) Certificate;
02. Domicile /Present Residence Certificate;
03. Diploma/ Degree Certificate;
04. Diploma/Degree Marks Certificate (Year Wise).
05. Category Certificate, in case of reserved category candidates;
06. Character/Antecedent Certificate from J&K Police Department. In case the Character/Antecedent certificate is not available at the time of joining, the engagees shall be allowed to join, but the salary shall be released only after the character and antecedent Certificate is received from concerned quarters.
07. N.O.C from concerned District Industries Centre & Employment Exchange.
08. Agreement format prescribed under SRO-24 of 2019 dated: 10.01.2019
09. An undertaking in the shape of an affidavit to the effect:-
 - i) That in case an adverse report about his/her Character and Antecedents, Qualification, Date of Birth, Marks certificates and Present residence/Domicile certificate etc, if any, is received from the competent authority to whom the references shall be made by the concerned DDOs, the candidate shall have no right to claim his/her engagement as ANM and his/her engagement as such shall be deemed to have been cancelled ab-intio. He/she will not also claim for any dues from Govt. Medical College, Sgr. as well in that case.
