Pursuant to the selection list issued vide No: NGS/MC/21/Final-Sel/ANM/AAB-NHM dated: 01.03.2021 the services of the persons indicated in Annexure-A to this Order are hereby temporarily hired on contract basis as ANMs on consolidated monthly honorarium of Rs.12,000/- (Rs. Twelve thousand only) per month under National Health Mission Programme initially for a period upto 31.03.2021.

- O1. The hired persons from S. No: O1 to 30 shall join in the office of Medical Superintendent, L.D Hospital, Sgr. whileas S.No: 31 shall join in the office of the Medical Superintendent, G.B.Pant Hospital, Sgr. within O7 days positively from the date of issuance of this order, failing which their engagement shall be deemed to have been cancelled ab-initio without any further notice in this behalf and next candidate as per merit will be considered for engagement as ANM.
- 02. The hired persons shall be allowed to join only on production of the following documents:
  - a) Date of Birth Certificate
  - b)Matriculation Certificate
  - c) Domicile certificate
  - d) Degree/Diploma Certificate
  - e) Degree/Diploma yearwise marks certificates
  - f) No Loan certificate from District Employment Exchange and District Industries Department.
  - g) Any other document as required under rules.

- 03. The temporary engagement of the persons shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.
- 04. The services hired will be purely on temporary basis for a period upto 31.03.2021 and shall automatically cease/terminate once the scheme is over. It is emphasized that the services are not being hired against any substantive post and as such won't confer any right upon the hired persons for regular /permanent appointment.
- 05. The hired persons shall submit an undertaking in the shape of an affidavit duly attested by Ist Class magistrate to the effect:-

- 06. The term of contract is extendable subject to satisfactory performance of the candidate/approval of the competent authority and:
  - a) Availability of Budget/Funds
  - b) Continuation of such scheme.

- 07. The engagement shall be governed by other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.
- 08. The services of the hired persons shall be terminated in case their performance is not satisfactory/upto the mark.
