The tenure appointment of above NPSC doctors is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SRO. 364 of 2020 Dated. 27-11-2020.

The appointment of the above doctors is further subject to the following terms and conditions:-

1. Before joining the Department the selectee shall submit an affidavit duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
  - a. he/she is Non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
  - b. he/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - c. he/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
  - d. he/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him/her.
  - e. he/she leaving the job in midway shall not be entitled for any experience certificate.
  - f. he/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
2. The above NPSC doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
3. Due to COVID-19 Pandemic, the appointee are required to join within 07 days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
4. The Registrars/Demonstrators appointed on Academic Arrangement basis shall be paid as SRO. 365 of 2020 Dated. 27-11-2020.
