

CIRCULAR

It is has been observed that while abandoning Registrarship/ Demonstratorship by a doctor the concerned HOD's forward their prior notice very late, which results In lot of inconvenience to the Office bearers of Academic Section as well as DDO's.

In this backdrop all HODs of Government Medical College, Srinagar and Super Specialty Hospital, Srinagar are directed to implement the S.O. 364 Dated. 27-11-2020 in letter and spirit, especially when a doctor submit their prior notice who abandon his/her Registrarship/ Demonstratorship in midway should reach to the office of the undersigned within (05) days from the issuance of the prior notice otherwise they shall not be entertained for the stipend which has been kept on hold in accordance with aforesaid S.O.

Besides, all HOD's of Government Medical College, Srinagar and Super Specialty Hospital, Srinagar are impressed that as per S.O. 364 Dated. 27-11-2020 any Registrar/Demonstrator who shall not complete his/her tenure is not eligible for one month stipend except who will submit his/her one month prior notice.
