c. He shall remain disciplined during the tenure period, any kind of misconduct make his liable for termination

without any prior notice.

- e. He leaving the job in midway shall not be entitled for any experience certificate.
- f. He will not indulge himself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.
- The above NPSC doctors shall have to execute an agreement 2. with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar or can be obtain from the Academic Section of the College.
- The appointee is required to join within (10) days from the date 3. of issuance of this order failing which the order shall be deemed to have been cancelled.
