Consequent upon reliving of Dr. Sheikh Ajaz Rafeeq, Registrar (Non PSC) Department of Orthopedics, Government Medical College, Srinagar and pursuant to the recommendation of Selection Committee which met on 08th & 09st January 2020, Dr. Obaid Nisar who stand at Serial No. 01 in the waiting list is hereby engaged as Registrar, (NPSC), in the Department of Orthopedics, Government Medical College, Srinagar for a period of (01) year which can be extended upto (03) years, subject to the recommendation of HOD concerned.

The tenure appointment of above NPSC doctors is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SRO 24 of 2019 Dated. 10-01-2019.

The appointment of the above doctor is further subject to the following terms and conditions:-

1. Before joining the Department the selected candidates shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
 - a. He is Non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. He will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - c. He shall remain disciplined during the tenure period, any kind of misconduct make his liable for termination without any prior notice.

- d. He is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
 - e. He leaving the job in midway shall not be entitled for any experience certificate.
 - f. He will not indulge himself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.
2. The above NPSC doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar or can be obtain from the Academic Section of the College.
 3. The appointee is required to join within (10) days from the date of issuance of this order failing which the order shall be deemed to have been cancelled. The selected candidates are supposed to submit his joining report in the office of the Registrar Academics, Government Medical College, Srinagar before she is directed to report to the concerned Departments.
 4. The Registrar appointed on Academic Arrangement basis shall be paid as per Government Order NO. 59-HME of 2017 Dated. 25-10-2017.
