Whereas, in view of the extraordinary situation that has arisen due to the spread of COVID-19, the Govt. vide Order 347-(JK) HME OF 2020 dated: 28.03.2020 accorded sanction to the contractual appointment of those faculty members and paramedical and nursing staff in Govt. Medical Colleges, Srinagar and Jammu and doctors (Medical Officers, Consultants and Senior Consultants) and paramedical and nursing staff in the Health Services Department, Kashmir and Jammu who have retired on superannuation from these Institutions/Departments with effect from 31.03.2018 or are likely to retire within next six months;

Whereas, after issuance of the said Govt. Order, this Institution has received 29 applications from the Officers/Officials who have retired or are likely to retire within next six months for re-engagement on contractual basis;

Whereas, in order to scrutinize the applications as per norms, a Committee was constituted vide Order No: 909 of 2020 dated: 12.04.2020;

Whereas, after scrutinization of the applications, the constituted committee recommended that only technical personnel like doctors and paramedical/Nursing staff willing to work at the COVID- 19 Centers of Govt. Medical College Sgr be re-engaged on the terms and conditions laid down in the Govt. Order No: 347-(JK) HME of 2020 dated: 28.03.2020 and the applications received from non-technical/ministerial staff/Inferior staff/Lift

operators/Gardener do not hold any merit in terms of the above Govt. Order and recommended to be rejected.;

Whereas, for efficient management of the COVID patients, Nursing,, laboratory and Anesthesiology personnel are urgently required at the designated COVID-19 Centers.

Now, therefore, keeping in view the immediate requirement, sanction is hereby accorded to the re-engagement of following technical staff on contract basis for a period one year or till further orders whichever is earlier in the first instance.
