Pursuant to the recommendations of selection committee which met on 11-05-2020 for walk in interview for COVID-19 Emergency, the following Non PSC candidates who have applied for post of Registrar in the Department of Anesthesiology, Government Medical College, Srinagar are provisionally selected/engaged as Registrar on Academic Arrangement basis initially for a period of one year which can be extended on basis of good performance and conduct upto (03) years for MD (02) years for Diploma holders:-

The tenure appointment of above NPSC doctors is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SRO 384 of 2009 Dated. 14-12-2009. The appointment of the above doctors is further subject to the following terms and conditions:-

1. Before joining the Department the selectee shall submit an affidavit duly attested by the Judicial first class Magistrate to the effect that: -


- a. he/she is Non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
- b. he/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
- c. he/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
- d. he/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him/her.
- e. he/she leaving the job in midway shall not be entitled for any experience certificate.
- f. he/she will not indulge himself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.

2. The above NPSC doctors shall have to execute an agreement with the institution on a prescribed format (Form A1 with regard to the various terms and conditions applicable during academic arrangement.

3. The appointee is required to join within 07 days from the date of issuance of this order failing which the order shall be deemed to have cancelled.

4. The NPSC Registrars appointed on Academic Arrangement basis shall be paid a fixed consolidated remuneration of RS. 9,300/- plus grade pay of Rs. 5,400/alongwith DA and HRA as applicable under Rules.
