Consequent upon Non joining of Dr. Harminder Kour, Demonstrator (Non PSC) Department of Pathology, Government Medical College, Srinagar vide this Office Order No. 103-RA of 2020 Dated. 17-04-2020 and pursuant to the recommendations of Selection Committee which met on 19th March 2020, Dr. Maliha Afsar who stand at Serial No. 02 in the waiting list is hereby engaged as Demonstrator, (NPSC), in the Department of Pathology, Government Medical College, Srinagar for a period of (01) year which can be extended upto (03) years, subject to the recommendation of HOD concerned.

The tenure appointment of above NPSC doctors is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SRO 384 of 2009 Dated. 14-12-2009.

The appointment of the above doctor is further subject to the following terms and conditions:-

- 1. Before joining the Department the selected candidates shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that:
 - a. She is Non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. She will not participate in any kind of strike during the period of her tenure engagement. In the event she proceeded on strike, her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.



c. She shall remain disciplined during the tenure period, any kind of misconduct make her liable for termination without any prior notice.

d. She is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or

police station against him.

e. She leaving the job in midway shall not be entitled for any experience certificate.

f. She will not indulge herself in any private practice. In case she is found doing private practice her appointment shall

be terminated without any notice.

The above NPSC doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar.

The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have been cancelled. The selected candidate is supposed to submit her joining report in the office of the Registrar Academics, Government Medical College, Srinagar before she is directed to report to the concerned Department.

The Demonstrator appointed on Academic Arrangement basis shall be paid as SRO. 24 of 2019 Dated.10-01-2019.
