Permission for doing Internship training programme in favour of Mr. Peerzada Adnan Altaf - keeping the permission order in abeyance thereof.

Whereas, vide this office order No. SS/5771-84/MC Dated. 31-03-2020, Mr. Peerzada Adnan Altaf was allowed to pursue one year's rotatory internship training programme in this College w.e.f. 31.03.2020; and

Whereas, the office of the Divisional Commissioner, Kashmir informed the office of the undersigned that the said intern, namely Peerzada Adnan Altaf had posted on his facebook account some objectionable material, which reads as under: -

> "All Kashmiri should strongly demand change of name of SMHS (Shiree Maharaja hari/hooen singh lanati terrorist) to AB hospital or ABSAH Hospital (Ameer-e-Kabeer Sayed Ali Hamdani) It is Great Shame SMHS, one of largest hospital of 99% muslim Kashmir is named after terrorist Hari Singh L.A who butchered 5,00,000 Muslims in Jammu in 1947 for greed of power, but not named after Syed Ali Hamdani (RA)"

Whereas; Divisional Kashmir vide Div.Com/PS/Misc/2020/254-55 Dated. 15-05-2020 directed IGP police Kashmir zone and Principal Government Medical College Srinagar to take action against the accused immediately and to furnish the action taken report to his office by

11-05-2020; and

Whereas; the undersigned sought a report regarding work and conduct of the intern from the HOD SPM, Govt. Medical College, Srinagar, where the said intern was posted, as per the roster devised vide aforementioned order. The HOD SPM forwarded the apology tendered by the accused, excerpt of which reads as under: -

"I had written some objectionable remarks about Hari Singh in a state of stress and mental breakdown. I deleted that post immediately after I realized that I should not have written it. I will not repeat such mistake in future again I am once again sorry for my mistake"

Whereas, this office forwarded the apology along with affidavit cum apology deed, in original, to the Divisional Commissioner, Kashmir, submitted by the aforesaid intern, whereunder Peerzada Adnan undertook on oath that he will not commit such mistake in future; and

Whereas, the Divisional Commissioner, Kashmir vide his office communication No. Div.com/PS/Misc/2020/254-55 Dated. 15-05-2020 issued directions to the undersigned, which read as under: -

"....it is requested to reprimand in writing and keep him under watch, till he completes his internship from your college. Furthermore on the basis of his behavior and conduct a report may be sent to his office at the end of internship"

Whereas, reprimand note was issued to the aforesaid intern vide this office No.GMCS/Acad/SS7020-22 Dated. 08-06-2020, the abstract of which reads as under: -

"....Accordingly Mr. Mohd Adnan is asked to desist from such activities in future and mend his behavior failing which action as warranted under law and other relevant rules shall be taken against the erring intern"

Whereas, in the meanwhile this office received an application from Resident Doctors Association, (RDA) Government Medical College, Srinagar alleging therein that the said intern has again posted some objectionable material on Social Media against Dr. Shoket Ali Naik, PG-II year Department of Medicine, Government Medical College, Srinagar and other female intern, which is highly objectionable under the medical ethics; and

Whereas, after going through the contents of the application submitted by the RDA of the College, it transpires that the behavior of the intern, namely Peerzada Adnan has not changed even after he submitted the affidavit cum apology deed and even after serving an officially reprimand note upon him; and

Whereas, such misbehavior and misconduct of the intern is not tolerable at all as it imbibes and inculcate indiscipline and disobedience among the students/interns and is as such liable for punishment to be deterrent for rest of the students/interns; and

Whereas; besides above, the intern Peerzada Adnan was allowed to start his internship training programme, awaiting his registration certificate (provisional) from the State Medical Council due to lockdown throughout the Country, for which he had also submitted an affidavit prior to his joining the internship training programme, stating therein that he shall submit the provisional registration certificate from Sate Medical Council as soon as possible, which he did not submit as on date notwithstanding this office issued a notice to

the intern to produce the registration certificate, failing which his internship will be cancelled; and

Now, therefore, on the basis of repeated complaints received by this office against Peerzada Adnan Altaf as regards his misconduct towards his colleagues and posting of anti-national posts on his facebook account, which is highly deplorable and cannot be tolerated anywhere especially in a Professional Institution and accordingly the permission granted in favour of Peerzada Adnan Altaf to pursue internship training programme in this College vide this office order No. SS/5771-84/MC Dated. 31-03-2020 is kept in abeyance in respect of Peerzada Adnan Altaf.

In the meanwhile a Committee of the following HODs is hereby constituted to probe into the matter, in light of the communication received from the Divisional Commissioner, Kashmir, as above vis-à-vis complaint received from the Resident Doctor's Association. However, the Committee shall furnish its report within a period of two days from the issuance of this order:-

- 1. Head of the Department Medicine
- 2. Head of the Department E.N.T.
- 3. Head of the Department Surgery
