Applications on the prescribed format are invited from the eligible (not in-service) and desirous candidates for hiring services in the following disciplines as Senior Residents under S.O. 364 of 2020 Dated. 27-11-2020 (Academic Arrangement basis). However, application forms from in-service eligible candidates shall be entertained after fulfillment of all pre-requisites, in accordance with the relevant rules, as envisaged in the J&K Civil Service Rules 1979 and production of NOC from the parent department. The services of the candidates thus selected by the Selection Committee shall initially be hired for a period of one year, extendable upto 03 years subject to better performance of the candidates during their 1st and 2nd years of engagement, to be certified by the concerned HODs after completion of 1st and 2nd year of their engagement: -

18.	Neurosurgery	MS Surgery from an Institution duly recognized by the NMC. M.CH Neurosurgery / DNB Neurosurgery shall be given preference.
19.	Pediatric Surgery	MS Surgery from an Institution duly recognized by the NMC. M.CH Pediatric Surgery / DNB Pediatric Surgery shall be given preference.

Desirous candidates interested to apply for the post of Senior Residents at Government Medical College, Srinagar in the aforementioned specialties should download the prescribed application form the Website http://www.gmcs.edu.in of Government Medical College, Srinagar between 26-06-2023 to 15-07-2023 or they can had it from the Xerox Section of Government Medical College, Srinagar during the said period. Application forms completed in all respects should reach the office of the Registrar Academics, Government Medical College, Srinagar by or before 15-07-2023.

Terms & Conditions: -

- The selection of the candidates shall purely be made on academic merit, in accordance with the selection criteria, as envisaged in the <u>Government Order No. 282-JK (HME) of 2023 Dated. 04-04-2023 and no interview shall be held for the selection purpose.</u>
- 2. Incomplete application form(s) in any respect or do not have relevant certificates/documents attached therewith shall be summarily rejected without further notice.
- 3. Conditions for In-service/ Not In-Service Candidates: -



For in-service candidates: -

- The In-service doctor shall be paid salary as per their LPC.
- Applicants working in Director of Health Services, Kashmir/Jammu are required to submit their application forms along with No Objection Certificate from their parent Department without which their application forms shall not be entertained as envisaged in Circular No. 03-HME of 2019 Dated. 27.05.2019.
- Those in-service doctors who have already completed their tenure as Registrar/Demonstrator/Senior Resident in any discipline need not to apply and their application forms shall not be considered.

For (not in-service) Academic Arrangement Basis (AAB) Candidates: -

- Not In-service doctors shall be paid stipend in accordance with S.O. 364 of 2020 Dated. 27-11-2020.
- 4. The candidates shall have to submit their application forms in the office of Registrar Academics, accompanied with the following self-attested copies of the documents:
 - a. MBBS all terms marks sheet and qualification certificate.
 - b. MD/MS/DNB/MCh./DM qualification/degree certificate of the respective specialty.
 - c. Internship certificate.
 - d. Date of Birth Certificate.
 - e. NMC/Jammu and Kashmir Medical Council Registration Certificate.
 - f. Overall Position certificate(s) (1st, 2nd & 3rd). (if any).
 - g. Distinction certificate(s) in any subject (if any).
 - h. Subject wise position certificate(s) (1st, 2nd & 3rd). (if any).
 - i. Paper presentation in National/International Conferences. (if any).
 - j. Poster presentation in National/International Conferences. (if any).
 - k. Best paper/poster award (if any).
 - I. Best Video presentation certificate(s) (if any).
- 5. The candidates shall produce an Affidavit duly attested by the Judicial Magistrate declaring that: -
 - the applicant (in-service) has not done Registrarship/Demonstratorship/Senior Residency earlier within or outside J&K Union Territory. However, the candidate(s) who are not In-service can apply, but preference will be given to the fresh candidate(s).
 - he/she is a not In-service candidate the information if found wrong he/she shall be punished under Rules, (only for not In-service candidates).
- 6. A separate application form is to be filled in for each post/specialty and fee is to be deposited separately for each post applied for by the candidate.
- 7. The maximum age for eligibility to apply shall be 50 years as on 01-06-2023.



- 8. The selected candidate must submit an affidavit to the effect that he/she is not on the rolls of any Medical Colleges/Institutions of the country, which is pre-requisite in terms of NMC norms.
- 9. The Competent Authority reserves the right to any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- 10. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 11. In case any declaration by the candidate, is found false or if the candidate has willfully suppressed any material/information relevant to his/her appointment, his/her selection will be cancelled ab-intio liable for action as Warranted under rules.
- 12. There shall be a waiting list which shall remain in force for a period of six months from the date of issue of the selection list.
- 13. In terms of S.O. 364 of 2020 Dated. 27-11-2020, the appointment on Academic Arrangement Basis of the appointee shall be terminable on either side by serving a prior notice of one month or on payment of one month's salary by the appointing authority.
- 14. In case of a tie, candidates with higher academic merit shall be preferred. In case the tie remains unbroken, candidates with higher age shall be preferred.
- 15. Candidates shall not claim any experience certificate in case they abandon Senior Resident-ship prior to completion of first year.
- 16. Certificates cannot be accepted or counted which shall be produced after submission of form.
