
Whereas; your unauthorized absence from duty in the department directly hampered the teaching programme/patient care as well as other official activities of the Department; and

Whereas; your unauthorized absence case was forwarded to Administrative Department vide No. GS-MC/Assoc/RD/893 Dated. 09-08-2019 And it was recommended that an action as warranted under article 120 of J&K Civil regulation rules, may be initiated against you; and

Whereas; vide Government Order NO.290-JK (HME) of 2020 Dated. 18-03-2020 I, Dr. Waseem Qureshi, Registrar Academic Govt. Medical College,

Srinagar have been appointed as Inquiry officer to conduct Inquiry into your unauthorized absence.

Now, therefore you are directed to present yourself physically before the Inquiry officer on 29-07-2020 (Wednesday) positively failing which it will be construed that you have nothing to say in your defense and action as warranted under Article 128 of J&K Civil Services Regulations rules, may be initiated against you.
