Sanction is hereby accorded to the temporary appointment in terms of SRO-43 of 1994 in favour of Mr. Javid Ahmad Sheikh S/O Gulam Mohammad Sheikh and Late Zoona(Ex. Sweeper) R/O Rawalpora Srinagar as Sweeper in the pay level SL1(14800-47100) against the available vacancy in GMC Srinagar, subject to fulfillment of following conditions.

- a) The appointee shall report to the office of the undersigned within a period of 21 days from the date of issuance of this order.
- b) In case of failure of appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.
- c) The appointee shall be allowed to join only on production of the following documents/Certificates (except Character/Antecedent) to be verified subsequently by concerned DDO.
  - i. Date of birth certificate.
  - ii. Academic Qualification.
    - Middle Pass Certificate
  - iii. Health/Medical Fitness certificate issued by competent authority.
  - iv. Permanent Resident Certificate/Domicile Certificate of UT of J&K issued by concerned Tehsildar.
  - v. Dependent Certificate/Legal Heir Certificate issued by competent authority
  - vi. No Loan Certificate under self Employment Scheme from DIC concerned and non employment Certificate for concerned department.
  - vii. Character/Antecedent certificate from J&K Police Department.
  - viii. All Other relevant documents as are required under SRO-43 of 1994.
- d) The appointee shall be initially on probation for a period of 02 years.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 Dated:- 24/12/2009.
- f) The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case of adverse report about her character and antecedents is received, the candidate shall have no right to claim his appointment as Sweeper and his appointment as such shall be deemed to have been cancelled ab-initio.
- g) If on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.
- h) The salary of the appointee shall not be drawn and disbursed to him unless & until a satisfactory reports in respect of condition (c) and verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by this office.
