Whereas, vide this office Advertisement Notice No. 07-GS of 2019, dated 11.12.2019, applications were invited from the eligible candidates for filling up of various positions on contract basis under NHM for the District Early Intervention Center, (DEIC), in Government G.B. Pant/Children Hospital, Govt. Medical College, Srinagar;

Whereas, alongwith other positions, 01 posts of Clinical Psychologist with following eligibility criteria was also advertised vide aforesaid notification for selection/engagement of the suitable candidates:

**" M.Phil in Clinical Psychology/ 01 year Professional Diploma in Clinical Psychology."**

Whereas, in response to the said notification, 05 applications were received upto the cutoff date i.e 24.12.2019 for the post of Clinical Psychologist;

Whereas, on scrutiny of the applications so received, it was found that only one candidate was fulfilling the notified eligibility criteria;

Whereas, this post was advertised earlier also but could not evoke a healthy response;

Whereas, in view of poor response the matter was reviewed in consultation with all stakeholders/experts and the following eligibility criteria has been framed/fixed for engagement against the post of Clinical Psychologist:

**" M.Phil Clinical Psychology (02 years' course) OR  
M.A Psychology/Clinical Psychology (02 years course)  
with Post Graduate Diploma in Rehabilitation Psychology  
(PGDRP)."**


