The hired persons shall join in the office of Head of the Department Anesthesiology, Sgr. within 07 days from the date of issuance of this Order, failing which their engagement shall be deemed to have been cancelled ab-initio without any further notice in this behalf and next candidate as per merit will be considered for engagement as Anesthesia Technician.

02. The hired persons shall be allowed to join only on production of the following documents:-

- b) Domicile certificate
- c) (10+2) certificate
- d) Degree/Diploma Certificate
- e) Degree/Diploma yearwise marks certificates
- f) No Loan certificate from District Employment Exchange and District Industries Department.

03. The temporary engagement of the persons shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.

04. The services hired will be purely on temporary basis for a period of 03 months extendable upto six months subject to satisfactory performance of the candidate/approval of the competent authority and will cease/terminate once the scheme is over. It is emphasized that the services are not being hired against any substantive post and as such won't confer any right upon the hired persons for regular /permanent appointment.

05. The hired persons shall submit an undertaking in the shape of an affidavit duly

attested by Ist Class magistrate to the effect:-

That in case an adverse report about his/her character and (i) Antecedents, Qualification, Date of Birth, Marks certificates etc, if any, is received from the competent authority to whom the references shall be made by this office, the candidate shall have no right to claim his/her engagement as Anesthesia Technician and his/her engagement as such shall be deemed to have been cancelled ab-intio. He/she will not also claim for any dues from Govt. Medical College, Sgr. as well in that case and next candidate as per merit will be considered for engagement as Anesthesia Technician.

That he/she has fully understood the terms, conditions and (ii) of his/her engagement in Govt. Medical College, Srinagar under National Health Mission Programme will not claim for regularization

after completion of the term or at any point of time.

06. The term of contract is extendable upto six months subject to satisfactory performance of the candidate/approval of the competent authority and:-
