


GOVT. MEDICAL COLLEGE SRINAGAR.**AUCTION NOTICE**

The Auction of Unserviceable Dead Stock items of Govt. Medical College Srinagar was put on Auction on 24-07-2018, by the Govt. Auctioneer as per the Executive Engineer R&B construction Division 1st Srinagar letter no 4199-4203 dated 12/7/2018 the auction was rescheduled due to poor response of bidders vide this Office No:-Estates/MC / 358-61 Dated :- 11-08-2018 & No:- Estates/Mc/ 434-39 Dated:- 11-09-2018 on 29/8/2018 and 27/9/2018 respectively . As none of the bidders take part in the auction, a committee of the officers has been constituted vide order No: - 495-501 Dated: - 10-10-2018 for the purpose, who has proposed that the minimum bid of the scrap/dead stock be reduced, accordingly initial bid has been reduced and the auction of the scrap/dead stock items will be held on **15/11/2018 at 11.00 AM** in the premises of Govt. Medical College Srinagar as per the following rules and regulations:-

The Rules and Regulations are as under:-

- 1) The starting bid value is Rs, 1,50,000 (Rupees one lac fifty thousand only). All the interested bidders on publications of this Auction Notice can inspect the material to be Auctioned during any working day between office hours up to 12-11-2018.
- 2) Auction will be conducted in presence of Auction Committee, constituted vide order no- 495-501 Dated: -10-10- 2018.
- 3) The earnest money shall be deposited by the interested bidders in shape of CDR of Rs.,25,000 (Rupees Twenty five thousand only) pledged to Chief Accounts Officer, Govt. Medical College Srinagar Kashmir be deposited on 12-11-2018 up to 3PM. The GST shall also be submitted with EMD. The EMD shall not be entertained without valid GST number.
- 4) In case of holiday/untoward situation the auction shall be held on the following working day on the same time and venue.
- 5) Every interested bidder shall have to increase the bid not less than Rs, 1, 50,000. [Rupees one lac fifty thousand only]
- 6) The successful bidder shall necessarily have to deposit 50% of the final bid amount on spot and the balance amount within three days.
- 7) The successful bidder shall have to pay VAT/TAX etc. if any admissible under rules.
- 8) The auction committee reserve the right to accept/reject the bids without assigning any reason thereof.
- 9) Other terms and conditions will be announced on spot before auction, by the committee already framed.
