1. The following documents are mandatory to be kept along with the Technical Bid failure of which the bidder is subjected to be disqualified from the NIT without any further notice or as desired by the Sub-Committee.
  - Registration with H&ME Department.

  - GST registration.
  - Latest Valid Tax clearance certificate.
