4. Financial Bid/Price Bid should be kept along with Technical Bid in a separate sealed envelope and the rates quoted should be sealed with transparent tape duly signed by the bidder.

Medical College Srinagar by the Sub-committee constituted by Chairman, RCC in the presence of the bidders who wish to attend. In case of holiday on the date of opening of bid/bids, the same will be done on the next working day or whenever the members are available at the same venue, date and time.
