





Subject:- Submission of quotations for discount offers for supply of High Speed Diesel (HSD) for running of Central Heating System in Govt. Medical College & Its Associated Hospitals, Srinagar.

For and on behalf of the Governor of Jammu & Kashmir State, Sealed Tenders affixed with Rs.5/- revenue stamps are invited from the authorized/registered dealers of Oil Companies viz IOC, BP, HP etc. for supply of HSD in bulk quantity to Govt. Medical College & Its Associated Hospitals, Srinagar for the winter session 2016-17 (Starting from 15-11-2016 to 15-03-2017) on the terms & conditions given hereunder:-

The discount offer containing requisite documents and duly sealed superscribed as "Discount Offer for supply of HSD to Govt. Medical College & Its Associated Hospitals, Srinagar for the winter season 2016-17" should reach the office of the Member Secretary, Rate Contract Committee, Govt. Medical College, Srinagar latest by 08-11-2016 upto 03.00PM positively by registered post/speed post or to be delivered personally. The authorities shall not be responsible for any delay in receipt of an offer due to any reason whatsoever. The sealed offers will be opened on 09-11-2016 at 2.00PM or any other convenient working day by the committee assigned with the job.

1. The quoters/bidders are required to enclosed copy of Authorization of the Oil Company with their offers.
2. The quoters/bidders are required to offer/clear cut discount per liter of HSD on prevailing market rates of Oil companies for HSD for Srinagar city as on date of supply, which must be F.O.R. Govt. Medical College & Its Associated Hospitals, Srinagar inclusive of taxes, carriage and other charges. The discount offered must be written in figures as well as in words locked with transparent tape. The offers written with pencil or partly typed and partly hand written shall not be considered. Correction in the rates must be avoided.
3. It shall be sole responsibility of the successful quoter/bidder to ensure delivery of HSD in broad daylight only as and when ordered as per the requirement of the College/Hospital during the winter season 2016-17 to ensure trouble free functioning of Central heating of the hospital starting from 15th November, 2016 to 15th March, 2017. The supply of HSD shall have to be as per quality/destiny of the Oil Company's standards and shall have to be made in locked tankers as per Oil Company norms.
4. The successful quoter/bidder shall have to raise/submit the bill in triplicate at the time of each supply with his offered discount.
5. Payment is subject to successful inspection/verification of quality and quantity of the material (HSD) by the Committee constituted for the purpose at the specified site and in case any damage/discrepancy/variation with regard to quantity and quality/density of HSD is found/observed by the Committee members, such supplies would be rejected out rightly.
6. The Committee (assigned with the job of opening of the quotations and finalization of rates) reserves the right to accept/reject or cancel any offer or all offers in full or part thereof without assigning any reason.
7. Any other condition deemed fit in the best interest of Government Services shall be incorporated in the undertaking to be given by the successful quoter/bidder on non-judicial stamp paper duly attested by Ist Class Magistrate.
