Whereas, Medical Superintendent Govt. GB Panth / Children Hospital Srinagar had forwarded your case for grant of sanction for 30 days Earned Leave for performing Umrah with effect from 28-12-2019 vide letter No. EST/CH/3610-11 dated 24-12-2019.

Whereas, Medical Superintendent Govt. GB Panth / Children Hospital was requested to submit the requisite documents along with your posting details in terms of Circular Instructions issued vide No. 11-GAD (Vigilance) of 2018 dated 10-04-2018 vide communication No. AH-9/Est-II/1182 dated 02-03-2020.

Whereas, your case was forwarded to the Administrative Department for grant of permission / NOC for 30 days earned leave with effect from 28-12-2019 along with station leaving permission vide communication No. AH-9/Est-III/2104-05 dated 16-04-2020, however the permission/sanction was not accorded by the competent authority.

Whereas, Medical Superintendent GB Panth Hospital / Children Hospital Srinagar vide communication No. GBP/CH/3244 dated 13-12-2021 has sought necessary instructions regarding release of the pending salary for the month of January 2020 which has not been drawn and disbursed till date for want of the permission from the competent authority.

Whereas, by virtue of the above details, it clearly indicates that you have left the station unauthorisedly neither with the sanction of the competent authority not with station leaving permission and proceeding for a foreign tour is highly punishable under the service conduct rules.

Now, therefore, in view of the above facts, you are hereby directed to explain your position as to why the action contemplated under rules shall not be taken against you, your reply should reach this office within 10 days positively and shall route your reply through Medical Superintendent concerned.

In case of your failure to submit your statement of defence within the stipulated time period, it shall be presumed that you have nothing to say in your defence and the action as warranted under rules will be initiated against you without any further notice.
