
He is directed to report to the Head of the Department Microbiology Govt. Medical College, Srinagar for duties.

**Terms and conditions of engagement:-**

01. The engagee shall have to join his assignment within a period of (07) days, failing which his engagement as such shall be cancelled without any further notice and the candidate next in merit shall be considered for such engagement in his place.
02. The hired person shall submit the following documents in the office of the undersigned:-
  01. Date of Birth Certificate
  02. Domicile Certificate.
  03. Qualification Certificate.
  04. Diploma/Degree year wise marks certificate.
  05. No loan certificate from District Employment Exchange and District Industries Department.
  06. Any other document as required under rules.
03. The temporary engagement of the candidate shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.
04. The engagement of Data Entry Operator is purely on contract basis for a period of one year in the first instance.
05. This contractual engagement is not being made against any substantive post and as such will not in any case confer any right upon the engagee to claim extension or regular appointment.
06. The contractual term of one year is terminable even before his term expires without any notice/citing any reason in case his performance is not satisfactory.
07. The contractual term is extendable by one year beyond expiry of original contractual term at the discretion of the competent authority and subject to satisfactory performance of duties and continuation of the scheme and availability of budget/funds.

08. The contractual engagee shall be entitled to avail the leave as per the SRO 418 of 2007 Dated. 11-12-2007 read with SRO. 141 of 2014 Dated. 22-05-2014.
09. The contractual engagee shall be governed by other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.
10. The hired person shall submit an undertaken in the shape of an affidavit dully attested by the 1<sup>st</sup> Class Magistrate to the effect:-

- a. ***That in case adverse report about qualification, Date of Birth, Marks Certificates etc, if any, is received from the competent authority to whom the references shall be made by the concerned office, the candidate shall have no right to claim his/her engagement as Data Entry Operator and his engagement as such shall be deemed to have been cancelled ab-initio. He will not also claim for any dues from Govt. Medical College, Srinagar as well.***
- b. ***That he has fully understood the terms, conditions and nature of this contractual engagement and will not claim for regular appointment at any future date on the strength of this contractual engagement.***
- c. ***That he will not leave the department before the completion of one years's contract, however, abandoning/terminating of this engagement as the case may be required one month prior notice on earthier side, failing which the salary shall not be paid for one month to the incumbent which always remain in deposit with the Department and shall be released on completion of sanctioned terms.***
