- c. he/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
- d. he/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him/her.
- e. he/she leaves the job in midway shall not be entitled for any experience certificate.
- f. he/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
- 5. The above doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
