Whereas, on scrutiny of the documents submitted by the candidates with their applications, eight (08) candidates were found not

fulfilling the eligibility criteria hence not allowed to participate in the selection process;

Whereas, in view of large number of applications, the applicants were put to a common written test on 06.03.2021, comprising of 80 multiple choice questions;

Whereas, the response/answer scripts of the candidates who appeared in the written test were got evaluated as per the key framed by the Paper Setter/subject expert;

Whereas, on the basis of evaluation carried out in accordance with the key, the result of the candidates who appeared in the written test was declared vide this office Notification issued No. NGS/MC/21/Result/RS-I&II/MRU, dated: 08.03.2021;

Whereas, on the basis of marks obtained in the written test, 10 candidates in the ratio of 1:5 were shortlisted for **Research Proficiency Evaluation** against these two positions;

Whereas, the Research Proficiency Evaluation of the shortlisted candidates was conducted by the designated committee of experts on 13.03.2021;

Whereas, keeping in view the desirable qualification/experience required for these positions, the following criteria has been adopted for selection of the suitable candidates:

1.	<b>Weightage to the marks obtained in the written test</b>	<b>= 80 points</b>
2.	<b>Weightage to Research Proficiency assessment</b>	<b>= 10 points</b>
3.	<b>Weightage to Research Publications</b>	<b>= 05 points</b>
4.	<b>Weightage to NET/equivalent</b>	<b>= 05 points</b>
5.	<b>Total</b>	<b>= 100 points</b>

Now therefore, on the basis of weightage allocated to merit obtained in the written test, research publications, NET/Equiv. and overall performance of the candidates in the Research Proficiency Evaluation held on 13.03.2021, the **selection/waiting lists** against the notified positions of **Research Scientist I & II** are hereby issued as **Annexure(A) & B respectively** to this Notification.
