Pursuant to selection list issued vide notification No: NGS/MC/2021/SEL/OA, Dated: 18.12.2021, the following candidate is hereby provisionally engaged as Jr. Ophthalmic Assistant in the pay scale Level-4 (25500-81100) revised on Academic Arrangement Basis in terms of S.O.364 of 2020 Dated: 27.11.2020 in Govt. Medical College, Srinagar for a period of one year only or till such time the post is filled by the competent authority whichever is earlier:-

The terms and conditions of the engagement are as under:-

A	Pay scale and salary	Consolidated pay equal to the revised basic pay, which corresponds to the minimum of the Pay Scale (5200-20200+2400) pre revised scale plus Dearness Allowance. Engagee shall also be entitled to HRA as applicable to in-service candidate carrying the minimum of revised scale subject to the fulfillment of conditions provided under relevant rules in this regard. Engagee shall not be entitled to any other monetary benefits, whatsoever.
B	Date of commencement of one year appointment	Date of signing of agreement.



C	Other Conditions of Service	Engagement shall be terminable on either side by prior notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. Engagement shall be terminable without any further notice, whenever the post is filled – up under rules by the competent authority and the engage shall have no claim, whatsoever, against the Government or the Appointing Authority. In the matter of discipline and conduct, the engage shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject.
E	Agreement to be signed	Selected candidate shall be allowed to join only after he signs an agreement as per format prescribed as Form-A appended to S.O. 364 of 2020, dated:- 27.11.2020.
F	Nature of engagement	The engagement made herein shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the engage for regular appointment against the post of Jr. Ophthalmic Assistant.

The above engaged candidate shall report to the Office of the undersigned within 21 days positively and shall be allowed to join on the production of the following certificates in original and signing of the requisite agreement as mentioned above:-

01. Matriculation (Date of Birth) Certificate;
02. Domicile Certificate;
03. 12<sup>th</sup> Class Marks Certificate;
04. Diploma/ Degree Certificate;
05. Diploma/Degree Marks Certificate (Year Wise).

09. Agreement format prescribed under S.O. 364 of 2020, Dated: - 27.11.2020.
10. The temporary engagement of the candidate shall be subject to the outcome of the writ- petition, if any pending in the Hon'ble court of law.



11. An undertaking in the shape of an affidavit to the effect:-
- i) That in case any adverse report about Qualification, Date of Birth, Marks certificates and Domicile Certificate etc, if any, is received from the competent authority to whom the references shall be made by the concerned DDO, the candidate shall have no right to claim his/her engagement as Jr. Ophthalmic Assistant and his/her engagement as such shall be deemed to have been cancelled ab-intio. He/she will not also claim for any dues from Govt. Medical College, Sgr. as well in that case.
  - ii) That he/she has fully understood the terms, conditions and nature of his/her engagement in Govt. Medical College, Srinagar on academic arrangement basis and will not claim for regularization after completion of the term or at any point of time.
12. The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.
13. The Services of the engaged person shall be terminated in case his performance is not satisfactory/upto the mark.
14. The respective DDOs shall keep the salary of the aforesaid contractual staff on hold till the completion of all the requisite formalities/verification of his documents.
