

Pursuant to the recommendations of Selection Committee which met on 21st February 2022 and verified the antecedents from Criminal Investigation Department (CID), Dr. Shoaib Mohmad Khan, an Inservice candidate, who has applied for the post of Demonstrator in the Department of Microbiology, Government Medical Srinagar is provisionally engaged as Demonstrator, initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the concerned HOD.

The appointment of the above doctor is further subject to the following terms and conditions:-

1. Before joining the Department the selected candidate shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
 - a. he will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. he shall remain disciplined during the tenure period, any kind of misconduct make him liable for termination without any prior notice.
 - c. he is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
 - d. leaving the job in midway shall not be entitled for any experience certificate.
 - e. he will not indulge herself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.

2. The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidate is supposed to submit his joining report in the office of the Registrar Academics, Government Medical College, Srinagar before he will be directed to report to the concerned Department.
3. The appointee shall paid as per his LPC issued by his parent department.
