
The tenure appointment of above not in-service candidates is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SO. 364 of 2020 Dated 27-11-2020.

The appointment of the above doctors is further subject to the following terms and conditions:-

1. Before joining the Department, the selectees shall submit an affidavit duly attested by the Judicial Magistrate/First Class Magistrate to the effect that:-
  - a. He/She is not In-service candidate, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.



- b. He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeds on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - c. He/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
  - d. He/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against his/her.
  - e. He/she shall not claim any experience certificate in case he/she leave Registrarship/Demonstratorship before completion of first year.
  - f. He/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
2. The above not in-service candidate shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar.
  3. The appointees are required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
  4. The Registrars/Demonstrators appointed on Academic Arrangement basis shall be paid as SO. 364 of 2020 Dated. 27-11-2020.
