 - d. He/she shall not claim any experience certificate in case he/she leave Registrarship/Demonstratorship before completion of first year.

e. He will not indulge himself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.

The appointees is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed

to have cancelled.
