Terms and Conditions of the engagement:-

01. The applicants must be domiciles of UT of Jammu and Kashmir.
02. These contractual engagement are not being made against any substantive post and won't confer any right upon the hired persons for regular/permanent appointment. The contractual engageses shall have to furnish an affidavit duly attested by the 1st Class Magistrate to the effect that they will not claim for regular appointment at any future date on the strength of this contractual engagement.
03. The engagement will initially be made for one year and will be extended upto three years subject to the satisfactory performance of the candidates/approval of the competent authority and:-
 - a) Availability of Budget/Funds.
 - b) Continuation of this Scheme.
04. The contractual engageses shall be paid full salary corresponding to the minimum of the pay scale including all allowances as long as they remain in the service and actually perform their duties.
05. The contractual engageses shall be entitled to a casual leave of (15) days for the whole period of their contractual engagement of one year. Any leave beyond that period, on

whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.

06. The contractual engagement shall be terminable on one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority; provided that the appointment of the contracting party shall be terminable without notice by the appointing authority whenever the post is filled up on regular basis by it and in that case the contracting party shall have no claim against the Government/appointing authority.
07. The selection committee reserves the right not to fill up the post in case Administrative exigency so demands
08. If a contractual engagee at any point of time willfully neglect or refuses to perform his duties, the appointing authority shall immediately terminate his contractual appointee without any notice and he shall not be entitled to any salary for such period.
09. The candidates must be in possession of all required documents and no under process certificate shall be accepted/entertained.
10. If any candidate is already working in any other Medical College in the UT of Jammu & Kashmir, he/she should get **No Objection Certificate** from the concerned Head of the Institution; otherwise he/she will not be considered for selection.
