Subject: Disengagement of Paramedical Staff engaged on academic arrangement basis having completed six years of term in Govt. Medical College, Srinagar.

ORDER No.381 -Of 2023.

DATED. 01-06-2023.

Whereas; with the introduction of J&K Medical & Dental Education (Appointment on Academic Arrangement Basis) Rules, 2009 under SRO 384/2009 dated 14.12.2009 and subsequent amendments made therein from time to time, the Govt. Medical College Srinagar has been making engagement of Paramedical Staff/personnel on academic arrangement basis to overcome the shortage of Technical Staff required for patient care and smooth conduct of academic activities in the Institution;

And whereas; as per the aforesaid rules, a person can be engaged on academic arrangement basis initially for a period of one year extendable upto maximum of (06) years (one year at a time) subject to good performance and conduct or till selection/ promotion is made in accordance with rules of recruitment governing the respective posts, whichever is earlier;

And whereas; when the first lot of such candidates was about to complete six years' term they filed a writ petition No. 1718/2017 before the Hon'ble High Court for directions to respondents to regularize their services and the Hon'ble High Court vide its order dated: 08.11.2016 directed the respondents to allow the petitioners to continue on the posts occupied by them;

And whereas; after re-organization of State of J&K into Union Territory the above Writ Petition No. 1718/2017 was transferred to CAT, Jammu Bench and re-numbered as TA 990/2021. The said TA came

up for hearing before CAT, Jammu Bench on 4.3.2021 and the Hon'ble Tribunal disposed of the said TA, operative portion whereof is reproduced as under:-

"We, therefore, dispose of the TA directing the respondents to consider the cases of the applicants, in terms of the existing policy and relevant schemes governing regularization, if permissible under the rules, within a period of three weeks from the date of receipt of a certified copy of this order. Till then status quo be maintained with regard to the applicants."

And whereas; being aggrieved with the follow up action on the part of respondents, the applicants filed WP No. 603/2020 before the Hon'ble High Court, which was subsequently transferred to CAT Jammu bench and thereafter Srinagar Bench and re-numbered as TA 221/2021;

And whereas; in the meantime the J&K Services Selection Board issued an advertisement Notification No. 02 of 2021 Dated. 26-03-2021, whereby 1444 posts in Health & Medical Education Department were advertised for selection of suitable candidates against the vacant posts on regular basis;

And whereas; the applicants/petitioners filed writ petition No. 657/2021 before the Hon'ble High Court challenging the advertisement Dated. 26-03-2021. The said petition was transferred to CAT Srinagar bench and was re-numbered as TA5646/2021;

And whereas; the Hon'ble CAT, Bench Srinagar vide its order 15-11-2022 dismissed TA 5646/2021 and TA 221/2021 along with all the MAs and also vacated all interim orders issued earlier in the matter;

And whereas; being aggrieved of the above Order of the Hon'ble CAT, the applicants filed two writ petitions bearing No. WP(C)NO.2682/22 titled Mohammad Sameer & ors v/s UT of J&K and others & W.P (C)NO. 2683/22 Titled Javeed Farooq Mir and others v/s UT of J&K and Others;

And whereas; Division Bench of the Hon'ble High Court, vide Order dated. 31-01-2023 dismissed both these petitions and also vacated all interim directions, if any, issued in the matter;

And whereas; 308 (Three Hundred Eight) petitioners filed two SLPs bearing No. **SLP(C) No. 3981/203 tilted Munir Ahmad Sheikh and ors Vs. UT of Jammu & Kashmir & others AND SLP(C) No. 4003/2023 titled Wazira Akhter & ors Vs. UT of Jammu & Kashmir and others** before Hon'ble Supreme Court against the Judgement dated. 31-01-2023 passed by the Division Bench of Hon'ble High Court and the Hon'ble Supreme Court has been pleased to pass an interim order dated 24.02.2023 in both the SLPs, which is reproduced as under:-

“ There shall be status quo as regards the employment status of the petitioners till the next date of hearing”

And whereas; after dismissal of the writ petitions by Hon'ble High Court vide Order dated 31-01-2023, the J&K Service Selection Board started to recommend selection lists against the notified posts of this Institution;

And whereas; in light of this background and in view of the selections being recommended by the J&K Services Selection Board for various categories of paramedical posts & subsequently approved/forwarded by the Administrative Department, the matter was examined in this Office and it was observed that there is no justification in continuing with those incumbents on academic arrangement basis, who have completed maximum permissible extended term upto six years and do not have any interim relief/direction from any court of law;

And whereas; after due deliberations, it was decided to immediately disengage all such paramedics who have completed maximum permissible extended term upto six years on academic

arrangement basis and do not have any interim relief/direction from any court of law to pave way for adjustment of the newly selected candidates;

Now, therefore in light of the above stated facts and circumstances of the case, **93 (Ninety Three)** paramedical staff forming "**annexure A**" to this Order who have completed (06) years term on academic arrangement basis and do not have any interim relief/direction from any court of law for their continuation in this Institution, are hereby disengaged with immediate effect.
