If the candidate has taken loan for self employment from DIC/Employment Department, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self employment unit/ enterprise before joining the Government service. He shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his salary, DDO concerned shall obtain an affidavit the concerned appointee(s) relinquishment of proprietorship and stakes, if any, in such selfemployment unit enterprise and recovery to be made and also personally monitor its recovery.

The appointee(s) shall give an undertaking in the shape of an affidavit duly attested by Ist Class Judicial Magistrate to the effect that if on verification, their qualification/ date of Birth/ reserved category certificates from the concerned issuing authorities are found fake/ forged, their appointment as Junior Assistant(s) in Govt. Medical College and Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal
