As recommended by the selection committee constituted vide Govt. Order No: 398-JK (HME) of 2021 dated: 18.05.2021, sanction is hereby accorded to the engagement of (36) candidates as Anesthesia Technician indicated in **Annexure-A** to this Order as Anesthesia Technician temporarily on contract basis for a period of one year in the pay scale of Level-6 (35400-112400) for the newly established 500 bedded temporary COVID Hospital, Khonmoh, Srinagar.

Medical engaged candidates shall report to the Superintendent, (500) bedded temporary COVID Hospital, Khonmoh, Srinagar for further duties alongwith the following documents in original within a period of 21 days, failing which their engagement as Anesthesia Technician shall deem to have been cancelled:

- a) Date of Birth Certificate.
- b) Domicile certificate.
- c) Qualification certificates.
- d) Degree year wise marks certificates.
- No loan certificate from District Employment Exchange and District Industries Department.
- Any other document as required under Rules.
- g) Verification of Character and antecedents from CID.
- . 01. The temporary engagement of the candidates shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.
 - 02. This engagement will be purely on temporary basis for a period of one year extendable upto three years subject to satisfactory performance of the candidates/approval of the competent authority and :-
 - Availability of Budget/Funds. a)
 - Continuation of such Scheme. b)

- 03. The engagement will automatically cease/terminate once the scheme/period is over whichever is earlier. It is emphasized that the services are not being hired against any substantive post.
 - 04. The engaged candidates shall have to submit an undertaking in the shape of an affidavit duly attested by 1st Class magistrate to the effect:-
 - i) That in case an adverse report about his/her character and Antecedents, Qualification, Date of Birth, Marks Certificates etc. if any, is received from the competent authority to whom the references shall be made by this office, the candidates shall have no right to claim his/her engagement as Anesthesia Technician and his/her engagement as such shall be deemed to have been cancelled ab-initio. He/she will not also claim for any dues from Government Medical College, Srinagar as well in that case and next candidate as per merit will be considered for engagement as Anesthesia Technician.
 - ii) That he/she has fully understood the terms, conditions and nature of this contractual engagement and will not claim for regular appointment at any future date on the strength of this contractual engagement.
 - 05. The services of the hired persons shall be terminated in case their performance is not satisfactory/upto the mark.
 - 06. Salary for one month will be kept on hold as security deposit and will be paid to engagee after culmination of the contract and after he/she clears pending dues and returning all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
 - 07. The contractual engagees shall be paid full salary corresponding to the minimum of the pay scale including all allowances as long as they remain in the service and actually perform their duties.
 - 08. The contractual engagees shall be entitled to a casual leave of (15) days for the whole period of their contractual engagement of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.
 - 09. The contractual engagement shall be terminable on one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority; provided that the appointment of the contracting party shall be terminable without notice by the appointing authority whenever the post is filled up on regular basis by it and in that case the contracting party shall have no claim against the Government/Appointing authority.
