Pursuant to the recommendations of Selection Committee, which met on 14th March 2023 and verification of antecedents by Criminal Investigation Department (CID), Dr. Sheikh Imran Farooq, an In-service candidate, who has applied for the post of Senior Resident in the Department of Surgery, Government Medical Srinagar is provisionally engaged as Senior Resident, initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the concerned HOD.

The appointment of the above doctor is further subject to the following terms and conditions: -

1. Before joining the Department, the selected candidate shall submit an affidavit in the office of the Senior Resident Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate to the effect that: -
 - a. he will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. he shall remain disciplined during the tenure period, any kind of misconduct make him liable for termination without any prior notice.
 - c. he is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against his.
 - d. he shall not claim any experience certificate in case he leaves before completion of first year.

- e. he will not indulge himself in any private practice. In case, he is found doing private practice his appointment shall be liable for termination without any notice.
2. The appointee is required to join within (21) days from the date of issuance of this order, failing which, the order shall be deemed to have cancelled.
3. The appointee shall paid as per his LPC issued by his parent department.
