Whereas, vide Govt. Order No: 156-JK (HME) of 2021 dated: 03.03.2021 you were appointed as Lecturer in the Department of Neurosurgery, Super Speciality Hospital, Govt. Medical College, Srinagar;

Whereas, pursuant to above order you submitted your joining report in the office of the undersigned on 23.03.2021 (AN);

Whereas, vide Order No: 17-GS of 2021 dated: 25.03.2021 you were directed to report to the Incharge Head of the Department Neurosurgery Super speciality Hospital, Govt. Medical College, Srinagar, Sgr. for further duties;

Whereas, vide letter No: HOD/NS/SSH/112-21 dated: 20.04.2021 the Incharge Head of the Department Neurosurgery has reported that you are absent from your duties since joining;

Whereas, a show cause notice was served to you, vide this office letter No: GS-MC/L/Neur-Sur/SSH/743-47 dated: 23.04.2021 with the directions to resume your duties within three days positively;

Whereas, in response to above show cause notice you resumed your <sup>duties</sup> on 01.05.2021 after remaining unauthorizedly absent for (38) days;

Whereas, vide letter No: HOD/NS/SSH/198/21/MC dated: 05.06.2021 the Incharge Head of the Department Neurosurgery has once again reported that after joining on 01-05-2021 you sought few days to collect your household stuff from pathankote and since then you are unauthorizedly absent;

Whereas, absence from duty without leave or after the end of leave involves loss of appointment in terms of Article 128 of J & K CSRs.

Now, therefore, in light of the above, a final and last chance is being afforded to you to resume your duties **with immediate effect** and explain your position within (24) hours, failing which it shall be presumed that you have nothing to say in your defence and the matter for termination of your probation and discharge from the service will be recommended to the Administrative Department (H&ME), without any further notice to you.
