01. The hired persons shall submit the following documents in the office of the undersigned:-
 - a) Date of Birth Certificate.
 - b) Domicile certificate
 - c) (10+2) certificate.
 - d) Degree/Diploma Certificate.
 - e) Degree/Diploma year wise marks certificates.
 - f) No loan certificate from District Employment Exchange and District Industries Department.
02. The temporary engagement of the persons shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.

03. This engagement will be purely on temporary basis for a period of (03) months extendable upto six months subject satisfactory performance of the candidates/approval of the competent authority and :-

a) Availability of Budget/Funds.

b) Continuation of such Scheme.

04. The engagement will automatically cease/terminate once the scheme/period is over whichever is earlier. It is emphasized that the services are not being hired against any substantive post and as such won't confer any right upon the hired persons for regular/permanent appointment.

05. The hired persons shall submit an undertaking in the shape of an affidavit duly attested by 1st Class magistrate to the effect:-

- I) That in case an adverse report about his/her character and Antecedents, Qualification, Date of Birth, Marks Certificates etc. if any, is received from the competent authority to whom the references shall be made by this office. The candidates shall have no right to claim his/her engagement as Laboratory Assistant and his/her engagement as such shall be deemed to have been cancelled ab-initio. He/she will not also claim for any dues from Government Medical College, Srinagar as well in that case and next candidate as per merit will be considered for engagement as Staff Nurse.
- II) That he/she has fully understood the terms, conditions and nature of his/her engagement in Government Medical College, Srinagar under National Health Mission Programme (ECRP) will not claim for regularization after completion of the term or at any point of time.

06. The engagement shall be governed by other terms and conditions, as are not specifically mentioned herein this Order but are made applicable in case of such engagements any time by the contracting authority.

07. The services of the hired persons shall be terminated in case their performance is not satisfactory/upto the mark.

08. Honorarium for one month will be kept as security deposit and will be paid to engage after culmination of the contract and after he/she clears pending dues and returning all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
