Whereas, the below mentioned incumbents/petitioners by virtue of various orders were appointed as Junior Grade Nurses on migrant substitutes in Govt. SMHS Hospital Srinagar.

Whereas, among others the above petitioners were also regularised as Junior Grade Nurses on migrant substitute in Govt. Medical College in terms of Govt. order No. 574 of 2013 dated 24-10-2013 issued under endorsement No. HD/46/NG/2004 dated 24-10-2013 with effect from 16-05-2006, however it was exclusively mentioned in the Government order that only those officials may be allowed to join the department who are working regularily in the department; and

Whereas, the Medical Superintendent Govt. SMHS Hospital Srinagar vide letter No. Est-II/NP/7824 dated 26-12-2013 had intimated that the petitioners remained unauthorisedly absent with effect from the dates shown against each.

Whereas, the said petitioners were not allowed to join by the department on the provisions laid in the regularization order and the petitioners have moved to the Administrative department who intern have sought reasons for not allowing them to join and desired to furnish the factual report of the case with further direction to sort out the matter under their close intimation; and

Whereas, the Administrative Department was accordingly intimated with the full commentary/factual report of the case with a series of the communications; and and

Whereas, the petitioners have approached the Hon'ble High Court through a medium of writ petition titled SWP No. 1793/2014, Msr. Afroza Jan and Others Vs State of J&K & Others, where under directions were finally passed on dated 13-10-2016, the operative portion of which is reproduced as under:-

"in the above background the respondent No. 02 is directed to allow the petitioners to join their posts from tomorrow viz. 14-10-2016 onwards. Their joining and continuation is subject to outcome of the writ petition and notwithstanding the regularization order."

Whereas, on the above directions of the Hon'ble High Court and the opinion furnished by the Legal Section of the Department, the petitioners were allowed to join in the department in terms of this office order No. 707 of 2016 dated 12-11-2016 issued under endorsement No. AH/Est-II/456/Part file /10027-31 dated 12-11-2016 with effect from 14-10-2016 on the same terms and conditions as laid in the Hon'ble Court Order dated 13-10-2016; and

Whereas, this office has received Hon'ble Cenrtal Administrative Tribunal order under Transfer Application No. 2431/2021 dated 13-04-2022, the operative portion of which is reproduced as under:-

"... However, the period from the date of regularization till the date of joining of the applicants in the department is yet to be decided. Learned counsel for the applicants prays that the intervening period of applicants may be decided as leave not due and adjust the same when Leave infuture accured in the account of the applicants..."

"in view of the above, the respondents are directed to decide the intervening period of absence of the applicants as leave not due and adjust the same from the leave accured of the applicants in future..."

Whereas, as per legal opinion sought in the matter from the concerned Legal Section and on the directions of Hon'ble Cenrtal Administrative Tribunal order under Transfer Application No. 2431/2021 dated 13-04-2022, regarding settlement of the unauthorised period of the petitioners, it was opined to treat the unauthorised period of these petitioners as "Dies Non" in terms of Article 163 of J&KCSR 1956, however, a period of 5 months 27 days be treated as "Maternity Leave", if sanctioned by the competent authority in respect of serial No. 02 namely Hassina Bano.

Now, therefore, the department while taking the considerate view in the matter as per Hon'ble High Court and Central Administrative Tribunal order dated 13-04-2022, sanction is hereby accorded to the treatment of unauthorised period of absence the following petitioners as "Dies Non" from the dates / period shown against each in terms of Article 163 of J&KCSR 1956:-
