- 1. Before joining the Department, the selectees shall submit an affidavit duly attested by the Judicial Magistrate/First Class Magistrate to the effect that:
  - a. He/She is not In-service candidate, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.

- b. He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeds on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
- c. He/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
- d. He/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against his/her.
- e. He/she shall not claim any experience certificate in case he/she leave Registrarship/Demonstratorship before completion of first year.
- f. He/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
- 2. The above not an in-service candidates shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar.
