Pursuant to the recommendations of Selection Committee which met on 6th May 2022 and verified Characters and antecedents from Criminal Investigation Department (CID), Dr. Renuka Raina Not In-service Candidate who is applied for the post of Registrar in the Department of Obsts & Gynae, Government Medical College, Srinagar is provisionally engaged as Registrar on Academic Arrangement basis initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the Concerned HOD:-

The tenure appointment of above not an in-service candidate is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SO. 364 of 2020 Dated 27-11-2020.

The appointment of the above doctor is further subject to the following terms and conditions:-

1. Before joining the Department, the selectee shall submit an affidavit duly attested by the Judicial Magistrate/First Class Magistrate to the effect that:-
 - a. She is not In-service candidate, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. She will not participate in any kind of strike during the period of her tenure engagement. In the event she proceeds on strike, her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - c. She shall remain disciplined during the tenure period, any kind of misconduct make herself liable for termination without any prior notice.

- d. She is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against her.
 - e. She shall not claim any experience certificate in case she leave Registrarship before completion of first year.
 - f. She will not indulge herself in any private practice. In case she is found doing private practice her appointment shall be terminated without any notice.
2. The above not an in-service candidate shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar.
 3. The appointees are required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
 4. The Registrars appointed on Academic Arrangement basis shall be paid as SO. 364 of 2020 Dated. 27-11-2020.
