Sub: Engagement of Pharmacist on contract basis for the Newly established 500 bedded temporary COVID Hospital, Sgr. (Operating of waiting list).

ORDER NO: 136 OF 2021

Whereas, on the basis of merit obtained in the written test held on 09.06.2021, this office vide notification No: GS-MC/Sel/Pharma-AT/DRDO/1119-26 dated: 15.06.2021 issued the Selection/Wait list of the eligible candidates for engagement as Pharmacist on contract basis for the newly established 500 bedded temporary COVID Hospital, Khonmoh Sgr; and

Whereas, among others the selection of one candidate namely Ms. Amina Bano D/O Ab. Latif Mir R/O Check Arsalan Chitti Bandy Bandipora under ST category was kept withheld subject to resignation from the post of Class IV against which she is working on substantive basis in Govt. Medical College, Sgr.; and



Whereas, Ms. Amina Bano submitted an affidavit on 12.07.2021 duly attested by Ist class Magistrate to the effect that she is already working as Class IV in Government Medical College, Srinagar on substantive basis and is not interested to join as Pharmacist on contract basis; and

Whereas, keeping in view the above facts and dire need of paramedical staff for better COVID management, this Institution is left with no alternative but to operate waiting list for smooth functioning of COVID Hospital Srinagar; and

Whereas, as per selection list issued vide this Office Notification No. GS-MC/Sel/Pharma-AT/DRDO/1119-26 Dated. 15-06-2021, Mr. Yasir Yaqoob Mir S/O Mohd Yaqoob Mir R/O Mastan Khopri, Gurez is figuring at Serial No. 01 in the waiting list under ST category.

Now, therefore in light of above stated facts and circumstances, the selection of Ms. Amina Bano D/O Ab. Latif Mir R/O Check Arsalan Chitti Bandy Bandipora under ST category as Pharmacist on contract basis issued vide notification No: GS-MC/Sel/Pharma-AT/DRDO/1119-26 dated: 15.06.2021 is hereby cancelled ab-initio;

Consequent upon the above and pursuant to the selection list issued vide notification No: GS-MC/Sel/Pharma-AT/DRDO/1119-26 dated: 15.06.2021, sanction is hereby accorded to the provisional engagement of Mr. Yasir Yaqoob Mir S/O Mohd Yaqoob Mir R/O Mastan Khopri, Gurez as Pharmacist under ST category on contract basis for a period of one year in the Pay scale of Level-4 (25500-81100) in the newly established 500 bedded temporary COVID Hospital, Sgr.

The engaged candidate shall report to the Medical Superintendent, (500) bedded temporary COVID Hospital, Sgr. for further duties alongwith the following documents in original within a period of 21 days, failing which his engagement as Pharmacist shall deem to have been cancelled ab-initio:

- a) Date of Birth Certificate.
 - b) Domicile certificate.
 - c) Qualification certificates.
 - d) Diploma/Degree year wise marks certificates.
 - e) No loan certificate from District Employment Exchange and District Industries Department.
 - f) Any other document as required under Rules.
 - g) Verification of Character and antecedents from CID.
01. The temporary engagement of the candidate shall be subject to the outcome of the writ petition, if any pending in the Hon'ble Court of Law.
 02. This engagement will be purely on temporary basis for a period of one year extendable upto three years subject to satisfactory performance of the candidate/approval of the competent authority and :-
 - a) Availability of Budget/Funds.
 - b) Continuation of such Scheme.
 03. The engagement will automatically cease/terminate once the scheme/period is over whichever is earlier. It is emphasized that the services are not being hired against any substantive post.
 04. The engaged candidate shall have to submit an undertaking in the shape of an affidavit duly attested by 1st Class magistrate to the effect:-
 - i) That in case an adverse report about his/her character and Antecedents, Qualification, Date of Birth, Marks Certificates etc. if any, is received from the competent authority to whom the references shall be made by this office, the candidates shall have no right to claim his/her engagement as Pharmacist and his/her engagement as such shall be deemed to have been cancelled ab-initio. He/she will not also claim for any dues from Government Medical College, Srinagar as well in that case and next candidate as per merit will be considered for engagement as Pharmacist.
 - ii) That he/she has fully understood the terms, conditions and nature of this contractual engagement and will not claim for regular appointment at any future date on the strength of this contractual engagement.

05. The services of the hired person shall be terminated in case his performance is not satisfactory/upto the mark.
06. Salary for one month will be kept on hold as security deposit and will be paid to engagee after culmination of the contract and after he/she clears pending dues and returning all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
07. The contractual engagee shall be paid full salary corresponding to the minimum of the pay scale including all allowances as long as he remain in the service and actually perform his duties.
08. The contractual engagee shall be entitled to a casual leave of (15) days for the whole period of their contractual engagement of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.
09. The contractual engagement shall be terminable on one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority; provided that the appointment of the contracting party shall be terminable without notice by the appointing authority whenever the post is filled up on regular basis by it and in that case the contracting party shall have no claim against the Government/Appointing authority.
10. If a contractual engagee at any point of time willfully neglects or refuses to perform his/her duties, the appointing authority shall immediately terminate his/her contractual appointment without any notice and he/she shall not be entitled to any salary for such period.
