In terms of Jammu & Kashmir (Compassionate Appointment) Rules, 1994, notified vide SRO-43 of 1994, sanction is hereby accorded to the temporary appointment in favour of Saqib Rashid S/o Late Abdul Rashid Dobi, Ex. Orderly Government Medical College Srinagar R/o Ganz Khud Jamallata Nawakadal Srinagar as Multitasking Staff (MTS) on compassionate grounds in the pay level SL1(14800-47100) against the available vacancy in Govt. Super Specialty Hospital Srinagar, subject to fulfillment of following conditions:-

1. The appointee shall report to the office of undersigned within a period of 21 days from the date of issuance of this order & in case of failure to join within the stipulated period, he shall forgo his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on production of the following documents/Certificates(in original) to be verified subsequently:-
  - a) Date of birth certificate.
  - b) 10<sup>th</sup> and 12<sup>th</sup> Academic Qualification Certificate(s).
  - c) Health/Medical Fitness certificate issued by competent authority.
  - d) Domicile Certificate of UT of J&K issued by concerned Tehsildar.
  - e) Dependent Certificate no. DCS/SM/379/9759 Dated:- 12-02-2022 /Legal Heir Certificate no. 304/TSS/MM/CH/21 Dated:- 05-02-2022 issued by competent authority
  - f) No Loan Certificate under self Employment Scheme from DIC concerned and non-employment Certificate for concerned department.
  - g) verification of character and antecedents have already been got verified From concerned authorities (photocopy enclosed)
  - h) All Other relevant documents as are required under SRO-43 of 1994.
3. The appointee shall be initially on probation for a period of 02 years.
4. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 Dated:- 24/12/2009.
5. The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect, that if on verification, the certificate(s) produced by the appointee is/are found fake/forged, the appointment shall be cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
6. The salary of the appointee shall not be drawn and disbursed unless & until a satisfactory report in respect of condition (2) above is received in his favour.
