Whereas, you were selected as Registrar (NPSC) in the Department of Ophthalmology, Government Medical College, Srinagar vide this Office Order No.195-RA of 2021 Dated. 10.07.2021, (among others), on Academic Arrangement basis under SO. 364 of 2020 Dated. 27-11-2020, initially for a period of 01 year which is extendable upto (03) years; and

Whereas, due to COVID-19 pandemic you were supposed to join the Department with (07) days i.e. on or before 16-07-2021 as per the terms and conditions envisaged in the selection order; and

Whereas, you have failed to join the department despite passing more than (19) days; and

Whereas, a notice vide No. RA-MC/R/Oph/1036-40/MC Dated. 30.07.2021 was served to you to submit your joining report within (03) days from the date of issuance of notice in the print media failing which your selection/engagement order shall be deemed to have been cancelled ab-intio and the next candidate whosoever in the merit will be allowed to join the department; and

Whereas, you have again failed to submit your joining report in the department; and



Whereas, a writ petition filed by you under WP(C) No. 156/2020 CM No. 4356/2020 whereunder Hon'ble High Court has passed the direction that: -

"the appearing for respondents submits that the selection process initiated by respondents for filling up the post of Registrar in the Department of Ophthalmology in Government

Medical College, Srinagar, resulting in selection and appointment of respondent No. 6, in the shape of order bearing No. 379-RA of 2020 Dated. 1-10-2020, has, because of the order passed by this court on 12-10-2020, become infructuous, therefore, the respondents initiated fresh process of selection, which resulted in selection of the petitioner and respondent No. 6 in terms of order dated. 195-RA of 2021 Dated. 10.07.2021.

In view of the statement so made and the orders produced the, the writ petition is disposed of with direction to the Principal, Government Medical College, Srinagar, to allow the petitioner to join to the post of Registrar Ophthalmology by or before 23-08-2021"

Now, as per the directions of Hon'ble High Court, through the medium of this notice last & final opportunity is provided to you to join physically by or before 23-08-2021 failing which your selection/ engagement order shall be deemed to have been cancelled ab-intio.
