

The tenure appointment of above NPSC doctors is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SO. 364 of 2020 Dated. 27-11-2020.

The appointment of the above doctors is further subject to the following terms and conditions: -

1. Before joining the Department the selected candidate shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
  - a. he/she is non-PSC, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
  - b. he/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - c. he/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
  - d. he/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him/her.
  - e. he/she is leaving the job in midway shall not be entitled for any experience certificate.
  - f. he/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
2. The above NPSC doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
3. Due to Covid-19 pandemic, the appointee is required to join within (07) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidate is supposed to submit her joining report in the office of the Registrar Academics, Government Medical College, Srinagar before they will directed to report to the concerned Department.
4. The Registrar appointed on Academic Arrangement basis shall be paid as per S.O. 364 of 2020 Dated. 27-11-2020.
