- 5. The engagement will be strictly as per standing guidelines of NRHM presently in vogue.
- 6. The hiring shall be governed by other terms and conditions as are not specifically mentioned herein but are made applicable in case of such appointments at any time willfully by the contracting authority.
- 7. If contractual appointee, at any time willfully neglects or refuses to perform his /her duties, the services shall be made terminable without any notice and he/ she shall not be entitled at any salary for such period.
- 8. The candidate shall have to join his /her duties within one week from the date of selection along with all requisite original testimonials for verification, failing which waiting list shall be considered/operated.

- 9. The candidature shall be cancelled in case it is found at any stage of hiring that any fact has been misrepresented or misconceived or any fraudulent certificate/s has been produced to avail the engagement.
- 10. The contractual engages shall have to furnish an affidavit duly attested by the 1st Class Magistrate to the effect that they will not claim for regular appointment at any future date on the strength on this contractual engagement.
- 11. The selected candidate shall have to execute an agreement to the effect that he/she will not leave the department before the completion of sanctioned term. Abandonment/termination of the arrangement will require one months' prior notice on either side, failing which the remuneration shall not be paid for one month to the incumbent which shall always remain in deposit with the department and shall be released on the completion on the sanctioned term.
