

The Tenure of selectees is on academic arrangement basis and will be governed by the rules and regulations as envisaged in SO. 364 of 2020 Dated 27-11-2020-

The appointment of the above doctors is further subject to the following terms and conditions:-

1. Before joining the Department, the selected candidates are supposed to submit their joining report along with an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate to the effect that:-
 - a. The selected candidates are required to have clearance from CID Department as Envisaged in Govt. Order No 528-JK(GAD) of 2021 Dated 21-06-2021 and 1003-JK(GAD) of 2021 Dated. 27-09-2021
 - b. He/She is Non-PSC, the information if found wrong the selectee shall be punished under Rules which could include recommendation for confiscation of the Registration of the Doctor.
 - c. He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeds on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - d. He/she shall remain disciplined during the tenure period, any kind of misconduct shall make him/her liable for termination without any prior notice.
 - e. He/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against his/her.
 - f. In the event of him/her leaving the Registrarship halfway he/she shall not be entitled to experience certificate.
 - g. He/she will not indulge himself/herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice.
2. The above NPSC doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be download from the official website of Government Medical College, Srinagar.
3. The appointees are required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
4. The Registrars/Demonstrators appointed on Academic Arrangement basis shall be paid as SO. 364 of 2020 Dated. 27-11-2020.
