Subject:-Final Show Cause Notice.

Whereas, Administrative Department vide No. ME/NG/70/2021/e-office have forwarded your application wherein they have requested to furnish the comments and leave account statement in respect of your application for grant of permission for 12 months leave without salary along with station permission.

Whereas, the Medical Superintendent Govt. GB Panth / Children Hospital Srinagar has reported that you are absconding from your legitimate duties w.e.f 05-07-2021 and you have left the station unauthorisedly neither submitting any leave application form nor have sought any station leaving permission.

Whereas, your leave application for "one year leave without pay" was rejected and the Administrative Department vide this office communication No. 3460 dated 12-08-2021 were intimated that your services cannot be spared as the department is facing acute dearth of the nursing staff.

Whereas, you are habitual of being on unauthorised absence and your case was settled in the preceding year with stern directions not to repeat such practice in future failing which your case will be processed for termination without any prior notice.

Whereas, you have been served upon duo notices by this office vide No. AH-9/Est-II/MC/2021/3844-46 dated 26-08-2021 and AH-9/Est-II/MC/2021/4551-52 dated 22-09-2021 to your residential address seeking the reply regarding your unauthorised absence from the legitimate duties.

Whereas, you did not bother to attend upon the instructions embodied in the correspondence presumably by appearing in person before this office or could furnish the reply to the notices served upon and it seems that you are not interested to resume the duties and it is difficult to ascertain your actual whereabouts whether you are staying within or outside the country.

Now, therefore, before your appointment as ANM is terminated, you are hereby directed to explain your position as to why the action contemplated is not taken against you, you should personally attend this office with your reply **by or before 20th November 2021** on any working day.

In case of your failure to report this office along with your explanation, it shall be presumed that you have nothing to say in your defence and your appointment shall be terminated with effect from the date of your absence without further notice in terms of **Article 128 of JKCSR 1956.**
