

**Subject: - Final Notice before termination of Services.**

- 1) Whereas, as reported by the Medical Superintendent Super Specialty Hospital Shireen Bagh Srinagar that you are on un-authorized absence from your legitimate duties w.e.f 08-03-2019.
- 2) Whereas, Medical Superintendent Super Specialty Hospital Srinagar called an explanation from you vide letter no: - SSH/EST-III/2019/473-76 Dated: - 29/04/2019, but there was no response from your side.
- 3) Whereas, the Medical Superintendent Specialty Hospital Srinagar called another explanation from you vide letter No:- SSH/EST-III/2019/1455-56 Dated:- 26/06/2019, but there was no response from your side.
- 4) Whereas, neither you replied to notices served to you, nor you responded to the repeated telephone calls from the office of Medical Superintendent SS Hospital Srinagar.
- 5) Whereas, a Show Cause Notice was served to you vide this office endorsement No:- AH-09/ESTIII/126-29 Dated:- 09/01/2020 which was also published in Greater Kashmir, Srinagar on 11/01/2019, but there was no response from your side
- 6) Whereas, Charge Sheet was issued in your favour vide this office letter no:- AH-09/ESTIII/874-76 Dated:- 19-02-2020 and were asked to explain your position within 7 days, but there was no response from your side.
- 7) Whereas, Memorandum along with Articles of Charge and Statement of imputations was issued to you vide this office no:- AH-09/EST-III/20/1202-03 Dated:- 03-03-2020 and were asked to submit your representation within 10 days ,but there was no response from your side.
- 8) Whereas, inquiry committee was constituted vide this office order No:- 291 OF 2020 Dated:- 11-07-2020 to enquire into your unauthorized absence, a notice was served to you by Chairman , inquiry committee vide no:- Legal/MC/73-77 Dated:- 02-08-2021 you were given reasonable opportunity of being heard and you were directed to appear before the inquiry committee along with your defense on 12-08-2021 at 11:00 am otherwise it will be presumed that you have nothing to say in your defense. But still there was no response from your side as usual.

In the above backdrop, the committee has furnished final report and recommended that the services of official concerned may be terminated ab initio.

Now you are hereby given last and final chance to appear before the undersigned along with your defense within 07 days of issuance of this notice failing which it will be construed that you have nothing to say in your defense and committee your services will be terminated ab-initio as recommended by inquiry Committee constituted into your unauthorized absence.
